Group Member Applications Sub-Committee

In this administration, the Group Member Applications Sub-Committee reviewed 11 applications for Group Membership of the IAAP. Five were for Group Membership with Training Status, six were for Group Membership without Training Status.

It is a great pleasure to see that many applications came from countries where the IAAP had previously accepted Developing Groups and offered Router Training. These were Chile (SCPA) and Colombia (SCAJ) from Latin America, Czech Republic (CIAP), Poland (AJAP) and Ukraine (UJA) from Central and Eastern Europe, Taiwan (TSAP) and China (CSAP) from East Asia. Among these groups those applying for Group Membership with Training Status, which means that in the future they will be independent and offer their own training, include Chile (SCPA), Colombia (SCAJ) and Czech Republic (CIAP). The applications of these groups demonstrate that the investment of the IAAP in these areas has fulfilled one of the Association's goals: the development of Group Members of Jungian analysts in countries where no Group Members of the IAAP existed previously and where training was facilitated by the IAAP for professionals who expressed strong interest in Analytical Psychology.

Other applications came from countries or regions where Group Members of the IAAP already exist. These were applications from the L'Association Psychanalystes Jungiens du Québec (APJQ) and Association of Analytical Psychologists, Russia (AAPR). The processing of these applications needs more time as all existing IAAP Group Members or Individual Members in the same country or region must be consulted and asked for a Letter of Opinion. It is a delicate task of the Sub-Committee to respect both the existing and applying Group Member.

Letters of Opinion pertaining to the L'Association Psychanalystes Jungiens du Québec (APJQ) were entirely positive. In the case of AAPR, the already established Russian Society for Analytical Psychology (RSAP) sent a letter of Opinion that did express certain concerns on the part of the RSAP regarding the name of the new Group Member and aspects of their plan for training. The Sub-Committee forwarded the letter to the AAPR which responded to the requests, by altering their original plan for naming the Group. Some additional consultation and mediation between two groups was necessary, and was successfully completed.

In this administration two applications have been withdrawn in the course of the review process. The Sub-Committee informed the Executive Committee of its final assessment, and recommended acceptance of the remaining 9 applications. The Executive Committee approved each application, and recommends the Delegates also accept these applications. The final decision will be made in the Meeting of Delegates where a two thirds majority is needed for acceptance. The 9 groups are the following:

APJQ (L'Association Psychanalystes Jungiens du Québec), GM with Training Status
AAPR (Association of Analytical Psychologists, Russia), GM with Training Status
ČIAP (Czech Institute of Analytical Psychologists), GM with Training Status
SCAJ (Colombian Society of Jungian Analysts), GM with Training Status
SCPA (Chilean Association of Jungian Analytical Psychology), GM with Training Status
AJAP (Association of Jungian Analysts in Poland), GM without Training Status
CSAP (China Society for Analytical Psychology), GM without Training Status
TSAP (Taiwan Society of Analytical Psychology), GM without Training Status
UJA (Ukrainian Jungian Association), GM without Training Status
